___ The Columbia County Barn Quilt Committee retains the right to remove the barn quilt from the barn quilt website, promotional materials, and tours if it is in disrepair or no longer visible from the road.

___ I agree to allow the barn quilt information (your name, address, and barn/barn quilt history) to be included in promotional materials for the Barn Quilts of Columbia County Wisconsin project, including website promotion.

___ I agree to allow the barn quilt to be included as part of any tour developed.
