Pesticide Applicator Training for 2021

With the growing number of COVID-19 cases in our county and state, your safety is our top priority. We have made some changes and added some new options to this year's private pesticide applicator training program (PAT) to help keep our communities safer. Here's how this impacts you:

- No in-person training is currently being offered
- Online training will be available beginning December 1, 2020
- If a person cannot complete the online training, self-study testing is also an option
- Online testing and limited in-person testing are both available this year

PAT Manuals

Training and/or testing must be paid for and a manual will be provided.

You can order manuals online at the PAT Store <u>https://patstore.wisc.edu</u> with a credit card, or use a mail form available at <u>https://go.wisc.edu/patbook</u> and send it with a check.

We have PAT Manuals available at the Columbia County Extension County Office. Our office is open daily from 8:00 am to 1:00 pm, and most days until 4:30 pm depending on educator availability. Call 608-742-9680 ahead of time to be sure someone is here to schedule your training/testing, collect your fee, and provide you with a manual.

Training:

Online training is available. To access this:

- 1. Visit the PAT Store at <u>https://patstore.wisc.edu</u>
- 2. Scroll down to "Private Applicator Training"
- 3. Select General Farming 100/101.
- 4. Chose B. "Online Private Applicator Training."

Cost is \$10 per person. Available trainings are:

- December 1-14, 2020
- January 1-14, 2021
- February 1-14, 2021
- March 1-14, 2021
- April 1-14, 2021
- May 1-14, 2021

After choosing a training from the PAT Store, you can begin anytime in the 14-day window you selected. However, just like the in-person training, you must complete it in one sitting. You will not be able to start and stop, except for the designated breaks that are built into the training. Allow yourself approximately 3.5 hours to complete.

After successful completion of the online training, you will receive a receipt that will allows eligibility of the passing rate of 50% when you take the test.

Testing: Online or In-Person

If an individual does not take the training, they are able to do the self-study option, which requires a passing rate of 70%

An online test will be available beginning with the December online trainings. Check the PAT Store website above for information regarding taking the online test.

A very limited amount of in-person testing will be made available ONLY for individuals who don't have online access. This is to reduce office traffic and limit potential person-to-person exposure. To schedule an in-person test:

- You must call ahead to the Columbia County Extension Office at 608-742-9680
- There is a 2-hour time limit per current Extension policy
- Masks MUST BE WORN while at the office
- Testing may be done individually or in small groups (<10)
- Cell phones are not allowed in the testing room; they must be left just outside the room
- Bring your manual, calculator, and pencils with erasers (you MUST bring your own supplies, the office will not be providing shared supplies to minimize possible disease transmission)
- Also, you must bring photo ID or notarized waiver for why you don't have photo ID

Columbia County in-person testing will be held in Room #2 of the Health and Human Services Building located at 111 East Mullett St., Portage with a limit of nine people per testing session. Enter the doors on the west end through the ADRC entrance. In-person testing dates and times are scheduled for:

It will be especially important this year to get your testing completed well ahead of when certification is needed. You may also consider the self-study option to get your testing completed sooner. We will do our best to provide in-person testing between now and Spring.
